MISSION AND ORGANIZATIONAL STRUCTURE

Introduction

India is an agrarian economy and agriculture continues to be the mainstay of the Indian Economy, whose contribution to the national gross domestic product is about 25% and provides livelihood for nearly 65% of the population. It provides employment to about 65% of the labour force, which accounts for nearly 27% of GDP, it contributes 21% of the total export and raw material to several Industries.

Agricultural sector has tremendous potential for expansion of employment opportunities and

consequently mitigating the levels of rural poverty. These objectives can be achieved only if concerted efforts are made to realize the untapped potential of this sector. Low productivity in many crops, imbalance in the regional development, post harvest losses and inadequate processing facilities are some of the major weaknesses. There is a greater need for efficient linkages between the producers and the consumers for expanding employment opportunities and increasing the rural income through better marketing of agricultural products.

Establishment of SFAC

Realizing that the prevailing need for creating a conducive environment for generating rural employment and enhancing farmers income, the then Hon'ble Finance Minister announced the decision of Government of India's new innovative for setting up of Small Farmer's Agri- Business Consortium in his budget speech for the year 1992-93 in the following words:

"Special attention needs to be paid to supporting innovative ideas for generating income and employment in rural areas through support to various types of agri-business".

The setting up of the Small Farmers' Agri-Business Consortium (SFAC) in 1994 was a sequel to the above announcement for bringing about and facilitating a farm-focus growth through new ventures in agro-based industries. SFAC has emerged as a Developmental Institution with its core aims and objectives focused on increased production and productivity, value addition, provision of efficient linkages between producers and consumers. SFAC deals with agriculture in its wider connotation, including fisheries and horticulture.

Vision and Mission of SFAC

As stated earlier, farming is the most important economic activity in the country. The growth potential in this sector is immense in view of the changing food consumption habits, which demands better quality and variety. In order to meet this market led need, new approaches are being developed in agriculture sector including projects in the farm to table chain. Successes in such endeavor require innovations and partnerships. Under these circumstance Entrepreneurs and the farm sector need to work in consort so that their needs are met in a sustainable

and cost effective manner. The vision of the SFAC is to facilitate this process by aggressively promoting agribusiness projects through its Project Development Facility and Venture Capital Assistance schemes, establishing forward and backward linkages with farmers, providing assured market to their produce thereby generating rural employment and enhancing farmers' income. This is seen as a new chapter in the history of agriculture where farmers/producers groups yield not only more foods but more products, jobs and higher income in the rural areas.

Organizational set-up

SFAC has been envisaged as a catalytic/facilitating agency to promote agri-business activities. After looking into the various options in regard to the legal form of this organization, Planning Commission decided that appropriate organizational form of SFAC would be a Society to be registered under the Societies Registration Act 1860. Accordingly, it was considered appropriate by the Government of India to register it as a Society under the Societies Registration Act, 1860, promoted initially by

Government of India and Banks. Thereafter, SFAC was registered as a Society on 18th January, 1994 and is functioning as a Developmental Institution under the aegis of Department of Agriculture & Cooperation, Ministry of Agriculture. During the year 2006-07, the total membership corpus of SFAC stood at Rs.10.95 crore. The above Corpus was contributed by the Promoter Members, Primary Members and Associate Members (with no voting right) as per details furnished below:

As per the Articles of Association of the Society, the total number of promoter members shall not exceed

beyond six with the Government of India being counted as one promoter.

Management and Administrative set-up

The Articles of Association of the Society provide for a total of 14* permanent non-elective seats for the Promoter Members on the Board of Management of the Society. Of this, the Government of India has nine non-elective seats, including the President and Vice President of the Society and seven* nominees of the President, with the other Promoter Members having only one non-elective seat each. The Promoter Members are in perpetuity and no Promoter Member is entitled to disassociate itself from the affairs and business of the Society, in accordance with the

provisions of the Societies Registration Act, 1860.

Under the existing provisions of Articles of Association there are 23* members in the Board of Management of SFAC.

The Board of Management of SFAC is chaired, exofficio, by Hon'ble Union Minister for Agriculture, as the President and the Secretary (Agriculture & Cooperation), Government of India, is the ex-officio Vice-President.

Resources of SFAC

The Society maintains a SFAC fund to which the amounts received from following heads are credited:

- 1. all sums of money that may be provided by the Government,
- 2. all subscriptions and charges received from the members,
- 3. all sums of money generated from gift commodities by the Society or received by it by way of grants and donations; and
- 4. all sums of money received by the Society in any other manner or from any other sources.

Establishment and other revenue expenses are being met out of interest earned on membership corpus fund and also from income derived from services

rendered for schemes related work. Donations, if any, received by SFAC are exempted from income tax under section 18(G) of Indian Income Tax Act 1961.

Annual Report 2014-2015

Venture Capital Assistance

SFAC is implementing a Central Sector Scheme for Agribusiness Development through Venture Capital Assistance (VCA) to qualifying projects, which promotes linkages with farmers for procurement of their produce as raw material and provides employment in rural areas and has term-loan sanctioned by any Notified Financial Institution such as nationalized banks, SBI and its subsidiaries, IDBI, SIDBI, NABARD, NCDC, NEDFi, Exim Bank, RRBs and State Financial Corporations.

Venture Capital Assistance under the Scheme is provided to meet the funding gap in the means of finance as worked out by the lending Financial Institution and is refundable back to SFAC after the repayment of term loan of lending Financial Institution as per original repayment schedule or earlier without interest or in four equal quarterly installments which will carry interest at the same rate as charged by the bank for the term loan.

During the year 2013-14, SFAC has sanctioned Venture Capital to the tune of Rs 79.91 Crores for 213 agribusiness projects across the country benefitting 15359 farmers by providing marketing support to their produce and generating employment to 9011 persons in rural areas.

During the year 2014-15, SFAC has sanctioned Venture Capital amount of Rs. 81.81 Crores to 272 agribusiness projects across the country with total private & instructional investment of Rs. 925.96 Crores. This has directly benefited approximately 11167 farmers for procurement of their produce by them and generating employment to approximately 9622 persons in rural areas. It is observed that SFAC has shown commendable performance in terms of physical and financial as compared to last year. Amount of Venture Capital sanctioned and released to agri-business projects is given at Annexure – I.

In order to provide financial assistance to farmers, producers and prospective entrepreneurs etc., SFAC has empanelled reputed institutions and consulting firms for preparation of bankable Detailed Project Reports (DPRs). SFAC also assigned the task of preparation of 113 bankable DPRs to empanelled consultants at a total cost of Rs. 113.73 lakh. The details of DPRs prepared under the Scheme are given at Annexure- II.

SFAC has been organizing awareness camps to publicize the VCA scheme all over India. Awareness Camps have been organized in 19 States across 159 districts level and 14 State level camps in the financial year 2014-15. These camps were attended by appropriately 15,000 participants, which included various officials including District Magistrates and other functionaries at the District level, along with bankers, chartered accountants, consultants, officials of NABARD, farmers and entrepreneurs. These camps proved to be useful in not only spreading awareness about the VCA Scheme but also helped in clarifying doubts and motivating participants towards the various initiatives in enterprise development across agriculture and allied sectors.


Equity Grant and Credit Guarantee Fund Scheme for Farmer Producer Companies

SFAC is also implementing the Equity Grant and Credit Guarantee Fund Scheme (EGCGFS) for Farmer Producer Companies from 1st January 2014. The Scheme is operational across the country. Through this scheme two major initiatives have been taken to support Farmer Producer Companies (FPCs) viz., support to the equity base of FPOs by providing matching equity grants upto a maximum of Rs. 10.00 lakhs and, secondly, setting up of a Credit Guarantee Fund to provide risk cover to banks which advance loans to FPCs without collateral upto Rs. 100.00 lakhs.

Outlay of the Scheme has been fixed at Rs. 150.00 Crore for financial year 2013-14. Out of this amount, Rs. 50.00 Crore are for Equity Grant Fund and Rs. 100.00 Crore are for Credit Guarantee Fund. However, the amount of Rs. 150.00 Crores was received at the end of Financial Year 2013-14, therefore, this is being utilized during current financial year 2014-15. SFAC is organizing awareness campaign on regular basis in different states to promote EGCGF Scheme wildly so far in 6 States, 97 District level campaign and 6 States level camps has been organized. Amount of Equity Grant and Credit Guarantee Fund Scheme for FPCs is given at Annexure – III.



Farmer Producer Organizations (FPOs)

SFAC was mandated by Department of Agriculture and Cooperation, Ministry of Agriculture, Govt. of India, to support the State Governments in the formation of Farmer Producer Organizations (FPOs). The initiative which started in 2011-12 under the two Central Sector Schemes for Vegetable Initiative for Urban Clusters (VIUC) and Integrated Development of 60,000 Pulse Villages in Rainfed Areas has expanded in its scope and covers special FPO projects being taken up by some State Governments under general RKVY funds as well as under the National Demonstration Project under the National Food Security Mission (NFSM) and Mission for Integrated Development of Horticulture (MIDH).

As on 31st March, 2015, against a target of 6.86 lakh farmers to be mobilized 4.73 lakh farmers have been identified and formed into 27,850 Farmer Interest Groups (FIGs). These FIGs further have been federated into FPOs and so far 272 FPOs have been registered and 395 are under the process of registration.

- 2. Oil Seed & Pulses procurement operation under MSP in Kharif 2013-14 and Rabi 2014 using FPOs as procurement agencies has been undertaken in 6 States, namely Andhra Pradesh, Gujarat, Karnataka, Maharashtra, Madhya Pradesh and Rajasthan with a total procurement of 71,880 MT valued at Rs. 244.03 Crore. The total number of farmers benefitted from this initiative is 29,095 and 56 FPCs were engaged in the MSP operation. SFAC has sold 65,617.67 MT of pulses and oilseeds procured under MSP for a value of Rs.245.80 crore.
- 3. SFAC has empanelled 62 Resource Institutions for FPO promotion during XII year plan. Details are available on our website. States can use these RI for FPO promotion directly.
- 4. We are engaged in field monitoring of VIUC in 29 States and are producing a State-wise monthly progress report. Based on information collected during these monitoring visits, we are also bringing out a monthly News Letter on VIUC.
- 5. As on 31st March 2015 under the KRISHIDOOT CONNECT, a total of 11,155 market players like NCDEX, Vadilal Industries, Reliance Fresh (Guj.), ITC, ADM India, DCM Shriram and Jubliant Fresh have been empanelled on the Krishidoot platform. Krishidoot platform has successfully generated transaction volume of 7,21,443 qtl. worth Rs. 206.92 Crore.
- 6. State Level Producer Company (SLPC): In view of the development of sustainable FPOs in the State, SFAC has decided to federate all registered FPOs of the State into on State Level Producer Company. In first phase, SFAC is supporting SLPC in 10 States namely Gujarat, Karnataka, Rajasthan, Madhya Pradesh, Maharashtra, Odisha, West Bengal, Telanagana, Uttar Pradesh and Uttarakhand.

So far, SLPCs in Gujarat, Maharashtra, Madhya Pradesh, Rajasthan, Telanagna, Uttar Pradesh and West Bengal have been registered.

7. Observing 2014 as "Year of Farmer Producer Organizations".

Given the importance of member based institutions of farmers, generally known as Farmer Producer Organizations (FPOs) in linking farmers to investments, technology and markets, it was decided by the Department of Agriculture and Cooperation (DAC) to observe the calendar year 2014 as the year of "Framer Producer Organizations (FPOs). This marked the beginning of a year long drive to increase awareness about the importance of FPOs among a diverse range of stakeholders: the farming community, State Governments, banks and other financial institutions, private sector companies, civil society organizations, media and elected representatives from panchayats to the national level.

This special focus on FPOs during the course of 2014 was meant to enable central and State Governments as well as all other stakeholders involved in promotion and development of FPOs to concentrate their efforts on these emerging institutions and create example of success that can be easily replicated.

As the National level Nodal Agency SFAC was tasked with supporting the implementation of activities in the Year of FPOs, SFAC marked this special year with a twelve month long intensive campaign of events.

8. Establishment of Kisan Mandi at Alipur, Delhi- Following the amendment to the Delhi APMC Act, due to which fruits & vegetables have been delisted from the monopoly of the Azadpur mandi, SFAC has launched a Kisan Mandi to provide a direct trading platform for farmers and Farmer Producer Organizations. To be established at Alipur in north Delhi, with budgetary support provided by the Department of Agriculture and Cooperation, the Kisan Mandi will be both a physical and online platform to enable trading in agricultural commodities, directly between producers and bulk / retail consumers.

The foundation stone of the Kisan Mandi was unveiled by Hon'ble Agriculture Minister, Radha Mohan Singh on 25th September, 2014. The National Buildings Construction Corporation (NBCC), a Central Public Sector Undertaking, has been assigned the turnkey task of designing, construction and maintenance of the Kisan Mandi

The following activities in respect of the Kisan Mandi have been undertaken so far:-

- i) A plot of land under the possession of the Delhi Milk Scheme (DMS), situated in Alipur block in North Delhi measuring 1.61 acres, has been transferred by the Department of Animal Husbandry, Dairy and Fisheries to SFAC for a period of five years on payment of token rent to develop the Kisan Mandi.
- ii) SFAC has selected a Strategic Management Partner (SMP), who will be responsible for the day-to-day operations of the Kisan Mandi, under the overall supervision and guidance of SFAC and develop the business potential of the platform.
- iii) Hon'ble Agriculture Minister, Shri Radha Mohan Singh laid the foundation stone for the development works of the Kisan Mandi at Alipur on 25th September 2014.
- iv) NBCC has finalized the concept and engineering drawings for the Kisan Mandi and is in the process of obtaining approvals from statutory authorities. Thereafter, the tendering process will begin and it is expected that the Kisan Mandi will be ready for use by June, 2015.
- v) SFAC has selected a vendor for development of transaction software of Kisan Mandi for online trading and management operations.
- vi) Even as the physical premises are under planning, Kisan Mandi has begun test marketing by sourcing fresh produce from FPOs around the country for sale in the Delhi / NCR area.
- vii) As on date, a total of 9691.88 qtl. Vegetables such as potato, onion, fresh greens and citrus of a value of Rs. 111.79 lakh have been sold through Kisan Mandi to organized retailers, wholesale buyers and small quantities through Delhi Milk Scheme kiosks to retail consumers.

4. Pulses & Oil Seeds procurement at Minimum Support Price

Small Farmers' Agribusiness Consortium, (SFAC) has been nominated as a Central Procurement Agency for pulses and oilseeds since November, 2012, following the approval of a proposal placed before the Union Cabinet by the Department of Agriculture and Cooperation (DAC). SFAC's unique procurement model utilizes registered Farmer Producer Organizations (FPOs) as the field level agency to physically conduct the procurement operations, with technical and logistic support as well as funding provided by SFAC. The logic of this model is that farmers themselves are the most appropriate agents for conducting procurement operations and their collective institutions (such as FPOs) are the most efficient and cost effective procurement agencies available.

A pilot procurement drive was undertaken during Rabi 2013 in 5 selected States using the agency of FPOs. Approximately, 574 MT of pulses were purchased directly from members of FPO and other small and marginal farmers by using FPOs as procurement agencies, which operate the centers at the village level itself.

In kharif-2013-14 ,SFAC procured 21600MT pulses and oilseeds from Gujarat, Maharashtra, Andhra Pradesh and Karnataka and in Rabi-2014, SFAC procured 50290 MT of Chana from 6 States namely Andhra Pradesh, Gujarat, Karnataka, Maharashtra, Madhya Pradesh & Rajasthan . Approximately 30,000 farmers have got benefit of MSP across 6 States.

5. Foot and Mouth Disease Control Programme (FMD-CP) of Department of Animal Husbandry, Dairying & Fisheries (DADF)

Small Farmers' Agribusiness Consortium (SFAC) was mandated by the Department of Animal Husbandry, Dairying and Fisheries (DADF) to function as a Project Management Agency (PMA) in 2013-14, to support the Foot and Mouth Disease Control Programme (FMD -CP) across various States in India.

Under this project, SFAC set up a Project Management Team to carry out the various activities as follows:

- Bid process management for fixing the rate contract through e-procurement process
- Placement of supply order and procurement of FMD vaccine
- Pre-dispatch inspection at the manufacturing sites
- Random delivery inspection in transit and during storage for cold chain maintenance
- Random on-site monitoring of the vaccination process on the field
- Collection of report from the states for physical progress of phase-wise vaccination programme (MIS)
- Bill processing and payment based on the guidelines of payment as per the tender
- MIS management for the FMD vaccine procurement & supply and physical progress of vaccination.

The progress updates on the various components of the PMA's activities are as follows:-

- Bid process management has been completed for the 2014-15 and 2015-16 and the rate contract is approved by the Department.
- FMD vaccine supply order was placed on IIL, Brilliant Bio and Intervet India Pvt. Ltd for the supply of 1249.46 lakh doses during the 1st phase of FMD-CP 2014-15.
- FMD vaccine supply order was placed on IIL, Brilliant Bio and Biovet for the supply of 1499.959 lakh doses during the 2nd phase of FMD-CP 2014-15.
- Supply of 1499.919 lakh doses of FMD vaccine in progress across 19 states including Bihar which is newly added State under FMDC programme.
- Random monitoring of FMD vaccination programme is being carried out across 19 States.
- Total fund of Rs.182.90 Cr. was received during 2014-2015 for the FMDCP programme and, Rs.153.002 Cr. was utilized up to 31st March 2015 for procurement and monitoring work under the programme.

- 1. The accounts are prepared on historical cost basis as a going concern following the mercantile system of accounting and recognizing income and expenditure on accrual basis, unless otherwise stated. - 3. Fixed Assets are stated at cost less accumulated depreciation. Depreciation on Fixed assets are provided as per written down value method at the rates prescribed in the Income Tax Rules, 1962, except lease hold building where value is amortized over effective life of lease.
- 4. Investments are valued at cost and are unquoted.
- 5. Leave salary, Provident Fund, Gratuity and Pension Contribution of employees on deputation are accounted for on the basis of claims as and when made by the parent organizations.
- 6. Grant funds received under different schemes have been shown separately and used as per need. The administrative charges and service charges as per the parameters of the individual scheme(s) and Interest Income from Deposits of such funds have been treated as income of SFAC and credited to Income & Expenditure account.

NOTES TO ACCOUNTS

1. M/s Laddakh Food Limited - Rs.25, 00,000/-.

The unit of the company at Laddakh was sealed by the Laddakh Autonomous Hill Development Council and a FIR no. 64/04 PS LEH under section 420, 468, 471 IPC registered against some of the directors of Laddakh Food Ltd. A writ petition filed before Hon'ble High Court of Jammu and Kashmir by borrower against the Laddakh Administration for de-sealing of premises and damages. SFAC likely to become a party in a Writ petition if pending and also one of the complainant in the above said FIR. The SFAC already issued a letter dated 12.07.2012 to the Chief Executive Officer of Laddakh Autonomous Hill Development Council, LEH, Laddakh, Jammu & Kashmir for refund of Rs 25 lakhs in case of auction or possession of premises or machineries by Laddakh Autonomous Hill Development Council. Notice dated 08.03.2013 issued to party through advocate. Action against promoter was initiated by Ladakh Hill Council and assets seized. Efforts to recover through Laddakh Autonomous Hill Development Council have been unsuccessful. SFAC filed complaint U/s 200 CrpC against borrower on 31.10.2014 before Chief Metropolitan Magistrate, Saket Court and mater listed for consideration on 08.07.2015.

2. M/s Gomukh Environment Trust – Rs.22,50,000/-

As per agreement made on 01.12.2006, and borrower agreed to repay the VCA of Rs 22.50 lakhs as per letter dated 11.08.2009. The borrower in his letter also agreed to repay the loan amount eight equal quarterly installment of Rs 2, 81,250/- each to the SFAC but the borrower failed to refund the same. A legal demand notice issued to the borrower on 20.07.2012 which is duly received on 23.07.2012 but borrower neither refund the VCA nor replied the letter. SFAC has filed the claim petition before the Indian Council of Arbitration. ICA passed award on 20.08.2014. SFAC filed Execution Petition for recovery of Award before Pune District Court on 25.11.2014. Next date of hearing is 25.07.2015.

3. M/s Good Samaritan Social Service Association - Rs.46, 02,000/-

As per agreement made on 08.08.2007 with M/s Exotic Juices Ltd., and as per the clause 7 of the agreement the borrower had to pay loan together with the interest in 8 equal installments during year 2010-11 but he failed to repay the VCA amount SFAC issued a legal demand notice on 20.07.2012. Borrower neither replies nor made payment after receipt of notice. SFAC has filed the claim petition before the Indian Council of Arbitration. The case reserve for award on 26.03.2015 by ICA.

4. M/s Assam Aroma Herbs Private Limited, Assam – Rs. 7, 15,000/-

An agreement executed between the SFAC and borrower on 15.05.2005. SFAC sent several communications to the borrower and to the lending bank for recovery of the VCA but the borrower failed to refund the VCA. Case is under Sole Arbitrator to adjudicate the claim of SFAC. Next date of hearing is 05.07.2015.

5. In following cases Venture Capital Assistance provided to the unit/borrowers has become due but has not been returned so far. The legal proceedings have been initiated in all these cases.

SFAC owns 26 two/three bed room DDA flats at Vasant Kunj, Sukhdev Vihar & Jasola Vihar, New Delhi, The Executive Committee of SFAC society, in its 35th meeting held on 28.02.2014, discussed its earlier decision to auction the flats owned by SFAC. During the discussion, MD, SFAC briefed the executive committee on the difficulties. Faced in arriving at fair valuation of the flats due to lack of expertise within SFAC. The EC resolved that efforts should be made to offer the flats to the Central Housing Pool and /or Public Sect. Undertaking. In this regard, SFAC had written a letter to DAC on dated 31.07.2014 to take up the matter with concerned Ministries for taking over the flats for Central Housing Pool or PSUs for acquiring them for their use.

7. The society is approved under Sec. 10(23C) (iv) vide order F. No. DGIT (E) /10(23C) (iv) /2011 of the Income Tax Act, 1961. Amount exceeding 15% of its income is accumulated for application, wholly and exclusively to the objects for which it is established from A/Y 2010-11. Therefore the period of accumulation of the amount has not exceeded five years and hence not included in the taxable income.
