TERMS AND CONDITIONS

1. The auction will be held in the NCUI Parking. The auction of all the vehicles will be held as a single lot. The bid will be confirmed in favour of the person quoting the highest rate in respect of that vehicle.
2. Only those bidders shall be eligible for bidding, who deposit refundable amount of Rs. 5,000/- (Rupees Five thousand only) by way of demand draft / pay order drawn in favour of SFAC, New Delhi 110016 on or before 18th December, 2020 up to 01.00 P.M. along with duly filled Annexure A. Writing their name, address, telephone/ mobile no. on the reverse side of the demand draft / pay order which will be refunded to the unsuccessful bidders after completion of auction process.

3. To be eligible for bidding, the Bidder shall alongwith depositing the earnest money for the vehicle; should submit Written Bid/bids in closed cover in Performa (Annexure 'A').
4. The bid shall not be less than the reserve price or written bid submitted, if any, in relation to the vehicle.
5. The committee will deal with the bidders directly and no middlemen/ agents/ commission agents etc. should be asked by the bidders to represent their cause and they will not be entertained by the committee. At the bidding, any bidder/s trying to form cartel with other bidders to otherwise influence the Bidding process may be evicted and his/their earnest money may be liable to be confiscated.
6. Conditional bid will not be entertained. If the bid is withdrawn by the concerned party at any time after it is provisionally accepted, the entire money already deposited by him shall stand forfeited.
7. The car shall be sold to the highest bidder inclusive of GST, if any on the basis of amount quoted in the bid
8. The Managing Director or Authorized Committee of officers, in its discretion, reserves the right to reject or accept any or all the bids, partly or completely, at any time without assigning any reason thereof. The decision of the Committee of Officers conducting the auction shall be final.
9. It shall be presumed that the bidder has fully inspected the cars before the auction. The committee shall not be responsible and shall not entertain any complaint in respect of any defect in the vehicle.
10. The officers /staff of the SFAC and their family members shall not be permitted to participate in the auction.
11. The successful bidder shall get the vehicle transferred in his name as per rules, at his own cost and responsibility, immediately on taking delivery and in any case within the time prescribed for this purpose and a copy of transfer certificate may also be submitted to this office for acknowledgement. SFAC shall not in any manner be concerned with or responsible for registration of the vehicles, and will have no liability whatsoever after the delivery of vehicle to the successful bidder.
12. Successful bidders has to make full payment in the form of DD/ Payee Order in Favour of SFAC within 7 days after confirmation, failing which the offer will be cancelled and the EMD shall stand forfeited.
